



Summer 2026 Camping Process Timeline

As of September 18, 2025
ALL DATES SUBJECT TO CHANGE

August 2025

- 4: Publish summer 2026 camping **CALENDAR**
- 25: Area **CAMP** and **WORK CREW** requests go live
- 28: **SUMMER STAFF** applications go live

September 2025

- 5: Area **CAMP** and **WORK CREW** requests completed by 11:59pm MST
- 8: Regions lock **AREA REQUESTS** and start the regional review
- 17: Regional review of **AREA REQUESTS** finalized
- 22: Divisional review of **AREA REQUESTS** finalized by 7:30 AM MST
- 24: Regional review of **WORK CREW REQUESTS** finalized
- 24: Divisional **ALLOCATION** begins
- 26: **ADULT GUEST** host and adult guest application goes live

October 2025

- 1: **WORK CREW** recommendation and application open
- 16: **CAMP** trips available in YL Connect Camp and Initial Reservation (IR) sent to the area camping responsible party via DocuSign
- 30: **IR CONTRACTS** due from area to camp by 11:59pm MST via DocuSign - no financial commitment

November 2025

- 3: **ADULT GUEST** host placement begins
- 12: Camping Services communicates **WORK CREW** spots to regions, camp directors, and camps.
- 14: Camps communicate with **ADULT GUEST** hosts to confirm assignment

December 2025

- 1: **ADULT GUEST** hosts confirm assignment
- 15: Regions and camp directors confirm **WORK CREW** spots
- 15: **R1 CONTRACT** sent to Area Camping Responsible Party via DocuSign

January 2026

- 1: **YOUNGLIVES** childcare application opens
- 5: **WORK CREW** RA placement period begins - camps begin communication immediately after applicant placement
- 15: **R1 CONTRACTS** due from area to camp by 11:59pm MST via DocuSign - deposit of \$50/spot
- 15: **WORK CREW & SUMMER STAFF applicant with disabilities** interest form is due

February 2026

- 13: **WORK CREW & SUMMER STAFF with disabilities** application and staff recommendation due

March 2026

- 2: Final day for **WORK CREW COACH** placement
- 13: **WORK CREW** RA placement period ends - regions place applicants on waitlist for camps to fill spots
- 13: **R2 CONTRACTS** sent to area camping responsible party via DocuSign
- 13: Final day for **SUMMER STAFF COACH** placement

April 2026

- 1: **R2 CONTRACTS** due from area to camp by 11:59pm MST via DocuSign - financial commitment 90%
